**Pandemic Unemployment Assistance (PUA)**

The new Pandemic Unemployment Assistance (PUA) program opened yesterday. The system was overwhelmed with inquiries and has been available intermittently. This is a great benefit for self-employed, independent contractors and others not usually eligible for regular state UI benefits, and we highly recommend that you be persistent.

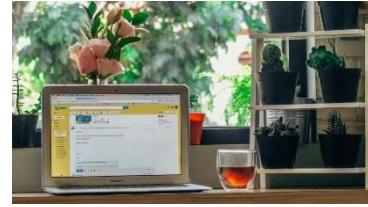

If you applied for an EIDL, you may contact the SBA's Office of Disaster Assistance for an update on your application. Please note that wait times vary and may be over an hour.

## **Independent Contractors & PPP Loan**

The SBA issued an updated [Interim Final Ruling](#) for the Paycheck Protection Program that included guidance for solopreneurs, independent contractors and single member LLCs to calculate their loan amount. As expected, borrowers will need to provide a 2019 IRS Form 1040 Schedule C to calculate an average monthly payroll amount, and a PPP loan amount.
